**Ballot:** Change the junior member dues as follows:

**If this proposal is accepted by the Board, it would become effective immediately for new Junior members. For existing Junior members, it will apply from their next membership renewal.**

**Rationale:** The Junior Exhibitor (JE) Committee has been updating TICA's Junior Exhibitor Program. A full proposal is expected to be considered at the Winter 2023 Board meeting. During the process of reviewing the existing program, several of the JE Committee and the TICA Board believe the Junior Exhibitor membership dues should be removed.

The JE Committee does not want membership dues being a deciding factor for our young exhibitors to participate in the Junior Exhibitor Program. We want to get juniors excited and enrolled in the program now, instead of waiting until after the Winter Board meeting when all of the proposed program changes are considered.

Rules quoted for Reference:

By-Laws 13.2.4 Junior Members. Those members under 18 years of age who pay junior membership dues. Junior members have the same rights and privileges as regular members except the right to vote and hold office.

Standing Rule 103.3.1 Membership dues shall be as follows
